



PUBLIC OFFER AGREEMENT
regarding the publication of authors' articles in the Economic Forum journal

1. Document Identification

- 1.1. This document is a public offer (hereinafter — the Offer) to conclude an agreement for the publication of authors' articles (hereinafter — the Agreement) in accordance with Article 633 of the Civil Code of Ukraine.
- 1.2. The current version is available at the following link: <https://e-forum.com.ua/en/licenseagreement>.
- 1.3. The placement of the text on the official website of the Economic Forum journal is an offer to an indefinite group of persons to enter into the Agreement under the specified terms.

2. Parties and Roles

- 2.1. Author = Licensor. An individual who created the article and submits it for publication.
- 2.2. Publisher/Editorial Team = Licensee. A subject of the publishing activity of the journal, accepting materials for publication.

3. Acceptance of Terms (Acceptance)

- 3.1. The Agreement is concluded by the Author's full acceptance of the terms without any conditions, exclusions, or reservations (Article 642 of the Civil Code of Ukraine).
- 3.2. Acceptance is considered to occur when the Author submits their materials for publication in the Licensee's publications after prior agreement on the content of the article between the Author and the editorial team.
- 3.3. From the moment of acceptance, the Author confirms they have read the terms of the Agreement and unconditionally accept them.

4. Licensing Model and Scope of Rights

- 4.1. The Author retains copyright on their work.
- 4.2. The Publisher obtains the right of first publication under the Creative Commons Attribution License International (CC BY).
- 4.3. The rights granted to the Licensee (without media restrictions):
 - publication of articles in English and distribution of printed versions;
 - translation into English (for articles written in Ukrainian) and distribution of printed versions of the translation;
 - distribution of electronic versions of the article and its English translation (for articles written in Ukrainian) by any electronic means (official journal website, electronic databases, repositories, etc.).

5. Verification of Rights Distribution

- 5.1. The fact confirming the distribution of rights between the Licensor and Licensee is the publication of the author's material in the Economic Forum journal.

6. Operational Publication Procedure (General Scheme)

- 6.1. Agreement. Preliminary agreement on the content of the article between the Author and the editorial team.
- 6.2. Submission. The Author submits materials to the editorial team.
- 6.3. Preparation and Distribution. Editorial preparation and publication or placement/distribution of the work within the rights defined in Section 4.

7. Liability

- 7.1. In case of non-performance or improper performance of obligations under this Agreement, the Parties shall be liable in accordance with the applicable law of Ukraine.

8. Dispute Resolution

- 8.1. Disputes and disagreements shall be resolved through negotiations between the Parties.
- 8.2. If no agreement is reached, the dispute shall be resolved in court under the laws of Ukraine.

9. Miscellaneous

- 9.1. In performing this Agreement, the Parties shall follow the legislation of Ukraine for all matters not directly regulated by these terms.
